- 16 That in case affiliation has been with certain conditions, the school will not start CBSE pattern classes without submitting a certificate/affidavit to the effect that the School has complied with all the conditions imposed by CBSE and the post- affiliation conditions contained in affiliation byelaws along with general rules.
- 17 That State pattern classes IX to XII running prior to the affiliation to CBSE would be sponsored for the State Board Examination.
